#### **TRIP PLANS FOR 2011**

Here is the latest information on planned trips for 2011:

1. Saturday, April 9 – PATH Harrison Shop tour. As of March 17, we had only three slots left before we reach our limit of a maximum of 30 people for this trip. 2. Here are some other dates for trips for the rest of 2011:

(a) Saturday and Sunday, May 21-22 - A Baltimore/Washington, D.C., weekend trip, focusing on trolley museums. On Saturday, we will visit the National Capital Trolley Museum, after which we will check into our hotel, which is walking distance from the New Carrollton station of WMATA. On Sunday, we will have a group breakfast at an Old Country Buffet, after which we will visit the Baltimore & Ohio Railroad Museum, followed by a visit to the Baltimore Streetcar Museum. Dinner will be on your own at the Inner Harbor area of downtown Baltimore. The flyer is included in this mailing. It should also appear at the ERA website, www.erausa.org.

(b) Saturday, June 11 - a Hudson-Bergen Light Rail trip, focusing on the new 8<sup>th</sup> Street extension, which opened in late January

(c) Saturday, July 3 –very tentative date for the 29<sup>th</sup> annual Grand Central Terminal tour. We are more hopeful now that this will happen, but please stay tuned.

(d) Saturday, August 6 – a visit to the LIRR Hillside and Morris Park facilities

(e) Saturday, October 1 – a day trip to Philadelphia to visit the Fern Rock and 69<sup>th</sup> Street Shops

(f) Saturday, November 5 – a visit to one of the NYCT shops, such as Coney Island or Westchester

(g) Saturday, December 10 – the annual Railroad Enthusiasts holiday trip to a place to be determined.
