Here is the latest information on trip plans for the rest of 2011:

- (a) Saturday and Sunday, May 21-22 A Baltimore/Washington, D.C., weekend trip, focusing on trolley museums. We now have reached or gotten close to the 25 minimum we need to run this trip, so the trip is definitely on.
