IN MEMORIAM – by Andrew Grahl

Traction fans and the Electric Railroaders' Association lost one of their own last month as well-known photographer and author Joseph P. Saitta passed away at the age of 70.

Joe was a very well-known traction fan who wrote countless books on the subject. He started the Traction Yearbook and the Traction Extra series in the 1980s while he was working on slide selling under the name Traction Slides International. Upon retirement from Long Island Bus, where Joe drove the streets of Nassau for many years, he helped his long-time friend Vincent Seyfried complete several books covering Queens history. He was also well-known for his fantastic black-and-white prints that were always available. Joe was a perfectionist when it came to photography. He always looked to capture the traction image with an interesting scene for all to enjoy. I remember Joe in his beloved Karlsruhe, Germany talking the Mayor into letting us photograph trolleys from the roof of City Hall. On a personal note, Joe was always very special to his friends. If he knew you had an interest, he would always remember you.

He is survived by his wife, Yolanda, who has always been by his side on various traction trips and events, his sons Michael, Danny, and Rick, and stepchildren Nena and Carlos. His grandchildren, including his beloved Vanessa, who was interested in traction photography, will all miss him terribly.
