The March meeting of the Electric Railroaders' Association will be held on Friday, March 15, 2013 at the St. John's University Manhattan Campus building, at 101 Murray Street, between Greenwich and West Streets, in downtown Manhattan. The University is a three block walk [1-1/2 blocks south and 1-1/2 blocks west] from the Chambers Street station of the West Side IRT Subway. ### **PROGRAM**

The March program will be presented by Nick DiBari. His digital presentation will cover a massive three and one half week trip to the United Kingdom in 2012, as well as a scenes from a 2010 trip to London and southeast England. The program will include the following systems:

- Manchester Metrolink, the first "modern" light rail system in the U.K.
- Glasgow their commuter rail system is the second largest in the U.K. next to London's; the Glasgow Subway, one of the oldest in the world (1896)
- Newcastle-upon-Tyne the Tyne and Wear Metro system; commuter, regional, and freight trains in the region
- York The National Railway Museum
- London and surrounding area London Underground; London Tramlink; various commuter and intercity trains; Isle of Wight rail line, a.k.a. the Island Line
- Closer to home various shots of our own N.Y.C. Subway will be shown

#### DENVER-SALT LAKE CITY TRIP UPDATE

Three months ago, you received a flyer inviting you to join us on ERA's 2013 Annual Convention featuring two of America's dynamic light rail cities, Denver and Salt Lake City. Reservations have been coming in far faster than usual. After three months, over 75% of ERA's Denver hotel room block is reserved. ERA's 70-seat reserved (and discounted) car is <u>fully booked</u>; however, members can still book the Denver-Salt Lake City travel on the same train on their own at Amtrak's individual fares so you can still join us in the dining, snack or observation car. Book Now Before It's Too Late!

If you are interested in participating, get your reservations and money for your tickets in as soon as possible. Booking deadline is (May 6, 2013 for hotel rooms) or whenever capacity is sold out at events, whichever comes earlier. The ERA Amtrak car between Denver and Salt Lake City is now fully booked **however** you can still book on the same train on your own while seats are still available (at the higher individual Amtrak fares). You can alternatively travel between Denver and Salt Lake City via Greyhound's inexpensive 2 daily trips or shuttle flights on Delta, Frontier or United Airlines, priced between \$100 and \$120 per person based on availability.

In addition to covering two of the nation's fastest growing urban light rail systems, members on this trip will also get to ride the iconic Pikes Peak Cog Railway, visit the Colorado Railway Museum, ride the Fort Collins Birney cars, see the historic Ogden Utah Union Station, travel on Salt Lake's commuter rail line and ride through the Rockies on Amtrak's California Zephyr train. This is a trip not to be missed!
