The April meeting of the Electric Railroaders' Association will be held on Friday, April 19, 2013 at the St. John's University Manhattan Campus building, at 101 Murray Street, between Greenwich and West Streets, in downtown Manhattan. The University is a three block walk [1-1/2 blocks south and 1-1/2 blocks west] from the Chambers Street station of the West Side IRT Subway. The doors open at 6:15 PM, and the meeting commences at 7:15 PM. Bring your 2013 membership card with you for admission. THE DOOR FEE FOR NON-MEMBERS IS \$5.00. #### **PROGRAM**

The sixth ERA tour to Europe took place between June 23 and July 3, 2000 and featured tours of all four of Hungary's tramway systems (Budapest, Debrecen, Szeged and Miskolc) as well as both tramway operations in Slovakia (Kosice and Bratislava).

In Budapest, we visited the tram system, the interurban system (including the tram museum in Szentendre), the subway museum, a ride on the historic 1896 subway car, and the subway shops.

Miskolc and Kosice have systems small enough that we were able to visit both in the same day. Debrecen and Szeged are not large systems but they were far enough apart to require their own day trips.
