The February meeting of the Electric Railroaders' Association will be held on Friday, February 17, 2017 on the second floor (Vanderbilt Suite) of the Roosevelt Hotel, 45 E. 45th Street (at Madison Avenue) in Manhattan. The Hotel is convenient to the 42nd Street stations of the Lexington Avenue and Sixth Avenue Subways, the Grand Central station of the Flushing Subway, and Metro-North's Grand Central Terminal. The doors open at 6:30 PM, and the meeting commences at 7:15 PM.

Program

The February slide program will be presented by Eric R. Oszustowicz. His program will encompass a wide and varied group of subjects, so there will be something for everyone.

Eric will begin by showing scenes of the New York area during 2016. This portion will include scenes of the New York subway system in addition to a brief review of transport-related subjects in the metropolitan area.

We then move on to a southwestern U.S. road trip taken in October. Extraordinary views of mainline freight railroading (BNSF and Union Pacific) will be included plus views of the Durango & Silverton steam railway and the Grand Canyon Railway. While in the southwest, we will see photographs of light rail operations in Los Angeles, San Diego, and Phoenix.
