The February meeting of the New York Division, Electric Railroaders' Association will be held on Friday, February 20, 2009 at the St. John's University Manhattan Campus (formerly the College of Insurance) building, at 101 Murray Street, between Greenwich and West Streets, in downtown Manhattan. The University is a three block walk [1-1/2 blocks south and 1-1/2 blocks west] from the Chambers Street station of the West Side IRT Subway. The doors open at 6:15 PM, and the meeting commences at 7:15 PM. Bring your 2008 or 2009 membership card with you for admission. ## PROGRAM

The February program (postponed from December) will be presented by Eric Oszustowicz. His slide program will focus on the French Riviera and western Switzerland with views of current events in the New York area interspersed. A brief look at public transport on various Caribbean islands and along the Amazon River in Brazil is also on the agenda. An update of railroading in the western United States will also be included.

The main portion of the program will include October 2008 views of the recently opened (and extremely photogenic) light rail system in Nice, France and the long established trolley systems in Geneva, Basel and Bern, Switzerland. Commuter and Inter City rail in all four cities will be shown in addition to views in Monaco and Cannes. The trolley coach systems in Geneva and Bern will also be covered in addition to other surface transport in all of the above venues.

The New York portion of the program will include a photographic chronology of the introduction of the new R160 subway cars and a brief look at the new PATH cars.

As you can see, the subject matter is diverse and unusual enough to appeal to anyone interested in public transit. Please join us for an interesting evening.

## TRIP PLANS FOR 2009

Here is the current list of tentative dates and proposed itineraries. Please keep in mind that all dates are tentative until a trip flyer is mailed. In some cases, no planning has yet been done and all future trips are subject to date changes and/or cancellation:

Saturday, February 21 – annual tour of Grand Central Terminal. Flyer included with this mailing

Saturday, March 28 – tours of the LIRR Hillside and Morris Park facilities. See the flyer with this mailing. All details have not yet been worked out with LIRR personnel, so the enclosed flyer is based on the best information to date. Watch for the flyer with the March mailing for further details, although we don't anticipate major changes

Saturday, April 18 – repeat of the Staten Island charter, utilizing the replacement diesels for the Alco S-1s. Although formal approval is still to come, a flyer is enclosed with this mailing so that you can reserve your place for this trip early. Again, there will be a capacity limit of 50 people per each of the two R-44 cars

Saturday, June 13 (changed from June 6) – joint trip with the New York Railroad Enthusiasts, tentatively involving a trip on the Metro North Port Jervis line (and lunch in Port Jervis)
