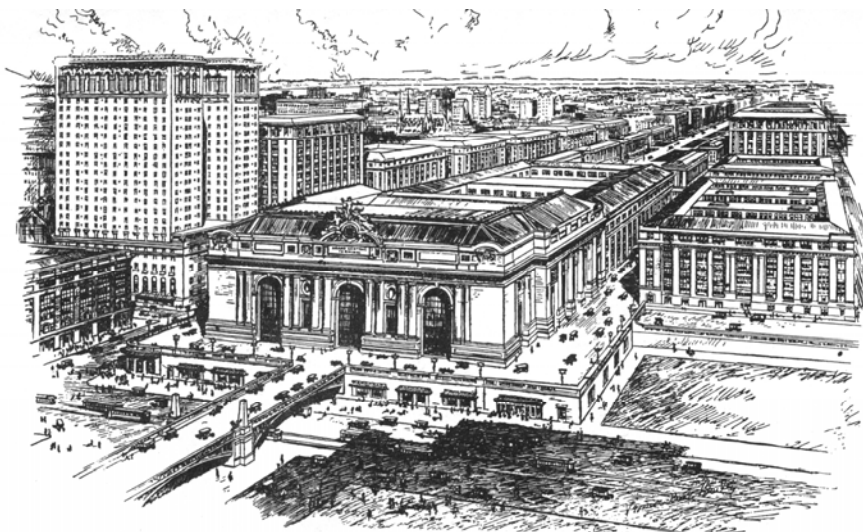


JOIN THE ERA FOR ITS 31<sup>ST</sup> ANNUAL TOUR OF:

This magnificent Terminal, officially dedicated on February 2, 1913, is now better than ever after comprehensive restoration work several years back. As most of you know, GCT is celebrating its 100<sup>th</sup> anniversary this year, making a tour that much more meaningful.

A representative of MTA Metro-North Railroad (most likely Dan Brucker) will be our host to point out interesting features of the Terminal, both old and new. In addition to the architectural and structural points to be visited, we hope to see various types of locomotives and car equipment. We will learn about upcoming plans for GCT, such as the LIRR East Side Access. There is always something going on at GCT, and you can have lunch before the tour (on your own) at one of the many restaurants in the Lower Level Dining Concourse or on the balconies.

Join us for a pleasant day of exploring one of New York's architectural masterpieces. The tour will meet in the Stationmaster's Office at 1:00 PM. The Stationmaster's Office is located under the West Balcony on the main level, next to the NY Transit Museum store. ### **DEPARTURE TIMES**

Each attendee is responsible for being at the departure point(s) several minutes prior to the scheduled departure time. With regard to the initial departure times, you should be aware that numerous g.o.'s are frequently in effect on the subways almost every weekend and these may delay your normal trip from your home or connection to the trip departure point. It is your responsibility to check for g.o.'s and other service notices that may affect your trip beforehand, so that you can plan your arrival time with plenty of cushion to spare. There will be no ticket refunds for failure to show up on time. It is important that you adhere to announced return departure times.

### **RULES OF CONDUCT**

The Electric Railroaders' Association, Inc. ("ERA") reserves the right to exclude from any and all meetings, trips and other activities sponsored by the ERA, any person who has engaged in disruptive behavior at any previous meeting, trip or other activity sponsored by the ERA. Also, the ERA reserves the right to remove from any meeting, trip or other activity sponsored by the ERA, any person who engages in disruptive behavior at that meeting, trip or other activity.

Disruptive behavior shall include but not be limited to the possession of alcoholic beverages, illegal drugs, illegal weapons or any other illegal substance or item.

### **APPROPRIATE DRESS**

If a trip involves walking through a rail shop or similar facility, appropriate footwear should be worn for each attendee's own safety. If a trip plan involves considerable walking, it is recommended that footwear be comfortable.
